Mindset Tips Before the Conversation

Before initiating a discussion about a prenuptial agreement, it's important to approach the conversation with the right mindset. How you frame the discussion can significantly impact how your partner receives the information and how productive the conversation becomes.



Lead with Love

Remind your partner that this agreement is about protecting *both* of you and building a solid foundation. Emphasize that your desire for a prenup stems from wanting to protect your relationship, not from lack of trust or commitment. Make it clear that this is a loving act of mutual protection.



Stay Curious

Be open to hearing their thoughts, feelings, and concerns. Listen actively without getting defensive. Your partner may have preconceptions about prenuptial agreements or emotional reactions that deserve acknowledgment and discussion. Create space for their perspective.



Avoid Surprises

Bring up the topic early—well before the wedding planning gets intense. Introducing the idea of a prenup too close to the wedding date can create unnecessary stress and may even raise questions about coercion. Aim to begin these conversations at least six months before your wedding.



Be Transparent

Talk about your goals, your values, and your financial future together. Share your complete financial picture, including assets, debts, income sources, and future inheritances. Transparency builds trust and helps both parties make informed decisions about the agreement's contents.

Remember that this conversation may need to happen over multiple sessions. Give your partner time to process their thoughts and feelings between discussions. The goal is mutual understanding and agreement, not just compliance.

"I want you to know that this isn't about distrust. This is about protecting *both* of us and making sure we're starting our marriage with honesty, respect, and a shared understanding. To me, having a prenuptial agreement isn't a sign that something will go wrong. It's a way to show that I'm committed to doing things right, together."



Sample Conversation Starters

One of the most challenging aspects of discussing a prenuptial agreement is simply starting the conversation. Many clients tell us they understand the benefits but struggle with how to bring up the topic without creating tension or misunderstanding. The following conversation starters can help open the dialogue in a non-defensive way:

"I've been learning more about prenuptial agreements, and I think it could be a helpful way for us to talk openly about money, goals, and our future. Can we set a time to explore it together?"

"This isn't about not trusting each other. I just think it's wise to have everything clear before we get married, so we're protected no matter what life throws at us."

"We're building a life together, and I want to make sure we both feel secure—financially and emotionally."

When initiating the conversation, choose a private, relaxed setting free from distractions. A neutral location where both of you feel comfortable can help create the right atmosphere. Avoid bringing up the topic during arguments, stressful times, or in public settings.

Pay attention to timing as well. Select a moment when you both have enough time to discuss the topic thoroughly without rushing. Weekend mornings or planned "relationship check-ins" can be good opportunities for these important conversations.

Remember that your tone and body language communicate as much as your words. Maintain open body language, make eye contact, and speak calmly. Frame the discussion as a collaborative planning exercise rather than a demand or ultimatum.



Key Questions to Reflect on Together

You don't need all the answers right away. These questions are designed to help both of you think about what matters most and guide your discussions as you work toward creating a prenuptial agreement that reflects your shared values and individual needs.

Financial Goals & Transparency

- What do we consider "ours" vs. "mine/yours"?
- What are our spending habits, savings goals, and money values?
- How much do we want to share financially, and how much do we want to keep separate?
- How will we handle dayto-day expenses and major purchases?
- What financial disclosures should we make to each other now?

Property & Debt

- What property are we each bringing into the marriage?
- Do we want to protect any family inheritances, businesses, or retirement accounts?
- How should we handle debts we had before marriage—or take on together?
- What happens to the family home in different scenarios?
- How will we treat property acquired during the marriage?

Unexpected Events

- How would we want things to be handled if we separated?
- What financial protections or expectations would feel fair?
- How do we want to approach support, like alimony or maintenance, if needed?
- What happens if one of us becomes unable to work?
- How might our agreement change if we have children?

These conversations might feel challenging at times, but they create important opportunities to understand each other's values and priorities. Many couples report that these discussions lead to greater financial intimacy and clearer shared goals for the future.

Consider revisiting these questions over several conversations rather than trying to address everything at once. This approach gives both partners time to reflect and can lead to more thoughtful, considered responses.

If disagreements arise during the drafting process, approach them as problems to solve together rather than conflicts to win. Focus on underlying interests and concerns rather than specific positions, and look for creative solutions that address both partners' needs.
